
Last Tuesday evening President Roosevelt carried this nation into the final mile of a dead-end road. A few more steps and we go over the fence into the holocaust of total war. The Chief Executive has said that he is going to shoot. When the Chief Gunner gives the command the youth of this nation will swing into line, marching to the same tune their fathers and uncles tramped to in 1917. And for the same empty slogans.

For us that section of Mr. Roosevelt's speech in which he declared open war on the organized labor movement is the most important. All of the rest-the convoys, the extent of our "borders," the "freedom of the seas," etc., he or his stooges have said, in one form or another for some time. But up to last week the president had used the "silk glove over an iron fist" tactic retaries and departments to make most of the pronouncements. Now the Chief Executive says-"this government is determined to use all of its powers . . . to prevent interference with the production of materials . . . collective bargaining will be retained, BUT . . . "

Roosevelt stated that from now on, the "voluntary" character of mediation and arbitration of labor disputes is to be compulsory, whether labor wants it that way or not. He said "that (mediation) machinery must be used promptly, and without stoppage of work . . collective bargaining will be retained, but the American people expect that impartial (?) recommendations of our government conciliation and mediation services will be followed by both capital and labor."

Everyone with any thinking power at all knows that Capital is very anxious to stop strikes. The bosses have never enjoyed paying the higher wages which strikes almost always bring the workers. Nor do they (the bosses) like the shorter hours, the seniority, nor the collective bargaining rights which millions of workers have won through striking. In fact, there is nothing the bosses would like better than to go back to the old "American Plan" days when the openship ruled the nation's "labor relations." Hence it is easy to see that this dictum of Roosevelt is aimed at the workers, and at them alone.

Roosevelt has already begun to use the powers he granted himself last week when he so dramatically announced that "a state of unlimited national emergency" exists. Monday's New York Times announced that "President to Test Axis War Threat by Seizing Ships." A sub head tells a further story-"Shaping his course alone." 

Now prices are taking an even faster spurt forward. Food prices have increased almost 1/3 as much in the past month as in the previous 20 months. The wholesale commodity price index is today at its highest level since October, 1937, and is moving up fast. Government officials have been astonished at the speed of this advance which in May has risen as much as a full percent in the course of a single week.

Higher Pay For Draftees Is Urged

An immediate and substantial ncrease in the rate of pay for the enlisted men in American armed forces was urged upon Congress last week by the annual delegated conference of the American Association of Social Workers meeting in Philadelphia.

The 150 delegates declared in a resolution that the present rates of pay for the enlisted man "involves him and his family in econmic difficulties.

The conference called for a genuine work program independent of relief, with work available to all persons who are able to work but who cannot find jobs in private industry. Such a program to be financed largely through Federal funds without requiring State and

local contributions. The delegates further approved resolution calling for "provision for allowances for families of men in service where loss of support has made such families dependent upon assistance programs."


