Prisoner Confesses When Given Third Degree — Taken to Scene of Crime.

## CHINAMAN CALM THROUGH ORDEAL

Saw Leon Hold Hankerchief in Sigel Girl's Mouth Through Keyhole.

Chung Sin, intimate friend of Willam L Leon, the Chinaman wanted for the murder of Elsie Sigel, was taken to the rooms he and Leon had scupled at 782 Eighth avenue, where the girl's body was found stuffed into a trunk, about midnight and badgered by Police Captain Carey, half a dozen shrewd detectives and Assistant District Attorney Ward, and was made to speat the confession wrung from him yesterday afternoon, when he told how he had seen Leon murder the Sigel girl.

As he stood in the dimly lighted com, almost on the spot where the trunk with its ghastly contents was found, Chung Sin calmly smoked a Unnerved by nours of questioning,

#### **CHURCH OF RUSSIA** BARS CREMATION

ST. PETERSBURG, June 23 .- The regulations elaborated by the Ministry of the Interior, providing for the introduction of cremation into Russia have been rejected by the Church au-thorities, who hold that the practice is in violation of the dogmas of the Orthodox Church.

The members of th echurch believe literally that the bodies of deceased persons are merely sleeping until the final resurrection, and the church insists upon divorce as a condition to renarriage in the case of widowers and sidows of persons who have cremated. The church authorities de clare that cremation would be pro-ductive of a new schism.



# PRESIDENT TAFT, TO TRY STRIKE LEADERS YOUNG MEN AND MEN THAT ROOSEVELT PLAN

#### Taft Government Fails to Redeem Irrigation Certificates--Western Farmers Get Hit.

(National Socialist Press Bureau.) WASHINGTON, June 23 .- One of the stock arguments of the superficially minded persons who offer quack remedies for social evils is that the unemployed proletarian should hike to the country and grub himself a luxurious living out of the soil. Jim Hill is wont to discant upon the bucolic joys which are being missed by those who have been forced into the city as a result of industrial evolution. It seems useless to point out the actual conditions that exist in the rural sections of the United States and how foolish such arguments are. People persist in repeating in this

Under the Roosevelt regime all sorts of schemes were got up to make him popular throughout the West and among the farmers and settlers. The fact that these things might some day re-act and claim as innocent victims the pioneers who had staked every thing on developing a homestead did not deter "Teddy" from launching these hot-bed fakes. It is significant that Secretary of the Interior Gar-field whom Roosevelt loved to call "Good Jim" and point to as the ideal American statesman, was the man who inaugurated the reclamation scheme Despite the howls about the neces

sity of people settling in the country the government had found from experience that there were far more settlers than there were homesteads So earnestly did the prospective, settlers press upon government reser vations that it became one of the per ideas of the Roosevelt administration to open up semi-arid tracts that would require irrigation. By no possible means could the government legally find money then or now to irrigate all this land.

Garfield "Winked the Other Eye." This did not deter "Good Jim" Gar-

field. "He "winked the other eye" at the land promoting speculators and corporations and announced that the settlers might organize "water users associations." These associations could assess themselves for a given amount, duplicate with an equal amount of labor, when the government would match this with a similar cash con-tribution on its part and issue cer-tificates for the amount of cash and labor expended by the settlers in lieu of the interest which the settlers had acquired in these government irriga-

tion plants. That is, an association giving \$100. 000 in cash and \$100,000 in towards irrigation would have expend ed on its plant \$200,000 by the gov-ernment. The government was to re-

rent against the navy.

It is pointed out that during the last ten years France has spent mor than \$600,000,000 on the navy, while Germany has spent rather less, but the two nations have exactly changed places as sea powers. France drop-ping from second place to fourth, and Germany advancing from fourth to second place.

The details of the report show many cases of official corruption and incom petency, and the commission urges a thorough reorganization of the navy department and a general overhauling of every branch.





#### A TIME TO KEEP COOL AND SANE.

It is the easiest thing in the world, when the people are excited over an atrocious crime, for a newspaper to fan the flames of their excitement, to rouse them to hysteria, to obscure their judgment and transform their righteous indignation into indiscriminate lust for vengeance, not against the guilty persons alone, but against whatever victims may most readily be reached, against a whole group, a whole community, a whole race.

That is what certain unscrupulous newspapers in the South systematically do whenever a crime is committed against a white woman and the finger of suspicion points at a colored man as the perpetrator. It does not matter much to them whether the actual criminal is caught or not. To investigate and weigh evidence calmly involves effort and self-restraint. It takes time, too, and offers less opportunity for demagogues to stand in the limelight. The simplest way, and the favorite way of the sensationalist, is to fix the guilt upon the whole black race and to raise the undiscriminating cry of "Lynch the nigger!"

That is what Krushevan and hundreds like him in Russia, Rumania, Hungary, and other parts of Europe have done against the Jews for centuries. By the easy arts of reckless insinuation and wholesale denunciation they have cultivated among great masses of the Christian population the sincere belief that the Jews as a race are monsters of iniquity.

And that is what the Hearst American is doing in New York today against the Chinese.

The murder of Elsie Sigel has come most opportunely for the Hearst paper's purposes. To incite race prejudice and jingoistic ment and, as a talented journalist aptmania is its settled policy. Particularly is it the Hearst policy to stir up feeling against the Asiatic peoples.


