The New York city budget for next year, as tentatively made up, was made public yesterday. Its total is \$163,049,480, as compared with this year's budget of \$156,545,148, an inrease of \$6,504,332.

"He destroys society and menaces vilization. We will fight against civilization. We will fight against our brothers and fathers if the welfare of the nation so requires. This is our irrevocable decision." In addition to the name of Estrada


