ACCUSED SUGAR MEN LOSE FIRST ROUND

Ex-Trust Weighers Turned Down. No Jury Yet.

The trial of James E. Bendernagel Oliver Spitzer, and four of the five Sugar Trust weighers, who are under indictment, began yesterday in the Criminal branch of the United States Circuit Court, before Judge James L. Martin, of Vermont. So much time was taken up in arguments for a demurrer by counsel for the defendants and by a motion to quash the indictments that when the court rose a few minutes after 5 o'clock the jury was not complete.

It was evident from the line of questioning adopted by the defense in its examination of the jurymen that no small amount of importance is altached to the influence on the public mind of newspaper and magazine articles, and of the published statements of Henry L. Stimson, special prosecu tor for the government. Also, the

very fact that the government's inter-ests are represented by a prosecutor other than the United S.ates District Attorney was emphasized by the de-fendants' lawyers. Judge Martin cleared up this point

however, late in the afternoon, when he said that whether the government was especially anxious to convict the defendants or not, the court and the jury were not to allow that fact to make a difference in their hearing of

Judge Martin added his belief that the present trial. statement followed a question submitted to a juror by Clarence K. Lexow, of counsel for the defendants, which formulated the suggestion that the government's specially employed counsel might influence him. e Court Decides Against Me Who Brought in Allen Labor.

WASHINGTON, Nov. 29,-That the government of the United States may through criminal proceeding, punish reons who conspire to aid allen con tract laborers to come into the United States, contrary to the immigration law, was held by the Supreme Court of the United States today in the prosecution of Tilden - B. Stevenso and Amede Bellaire.

These men, who reside in Boston were indicted in the Unite's States District Court in that city on the charge of aiding in the immigration of alle who were under contract to into in this country. Upon the trial of the men the court found that, while the law made a mindementor of the offense, it did not provide for any punishment of it, except by recovery of damages through a civil suit. Holding that a civil action would be exclusive of any other proceeding, the court dismissed the cass.

The government appealed to the Supreme Court with the result that it succeeded in obtaining a reversal of the decision of the lower courts. The opinion was by Justice Day.

Kasimirsky said that indignation over the tragedy was very great among the bakers and that it was expected that fully a thousand members of the union would be in line at the funeral today, including many from other locals.

AS TO INTELLECTUALS.

We have hitherto refrained from making any comment on any of the letters to the editor that have appeared in this paper since the last election. And we have particularly kept aloof from the controversy in the matter of "intellectuals vs. proletarians."

But in last Sunday's Call there appeared a letter by W. J. Ghent which compels us to violate the rule we have set to ourselves. That letter contained the following passage:

It [the doctrine of ultra-proletarianism] tends to give com-mon-sense men of whatever class who might be sympathetic toward its a totally false impression of the Socialist state and of Socialist of rilization. "Under Socialism," said one of our organs recently in really to an inquirer, "there will be no intellectuals." Possibly an organization in the proletarian might look forward engerty to such a blassful state; but no one to whom civilization has any meaning can possibly do so. The notion of a rockety in which all the triumphs of intellectual andersors a bless was been about a chipsel with the contraction of t of intellectual endeavor which man has slowly achieved through conturies of blood-letting and torture shall be dumped into the strap-heap is one that brings on r repulsion and disgust."

Now, in which "one of our organs" did the statement quoted by W. J. Ghent appear? Was it in some obscure Socialist paper published in some little out-of-the-way town? Why, no, it appeared right here in New York, in this very Call. Did it appear a few days ago, so that Ghent was impelled, for the good of our movement, immeto correct this horrible "notion that brings only repulsion and disgust" to every one "to whom civilization has any meaning"? Again we must say, no. The quotation appeared in The Call of

hearly four months ago that "repulsive and disgusting" statement appeared in The Call. All this time that statement was giving nmon-sense men of whatever class who might be sympathetic toward us a totally false impression of the Socialist state and of Socialist civilization," according to Ghent. But all this time Ghent allowed the "repulsive and disgusting" statement to go on doing mischief, without any attempt on his part to correct it, counteract it, and avrest it in its destructive career. Was he not clearly remiss in his daty as a Socialist, and a self-announced, self-pronounced, selfglorified intellectual to boot, "to whom civilization has a meaning"?

The reason for this astounding neglect of his duty by W. J. Ghent may appear from a reprint of the statement exactly as it appeared in The Call of August 11, 1909. It was as follows:

UNDER SOCIALISM.

Under Socialism, would the status of the intellectual be the same that of a manual laborer? Would it be fair?

New York, August 1, 1909.

IRVING RASKIN.

[Under Socialism there will be no intellectuals and no manual inhorers. You seem to have forgotten the fundamental aim of Socialism, the abolition of classes. In a society in which everybody wirks and no one appropriates the fruit of other people's labor, everybody is free to develop his intellectual powers.—Ed. The Call.]

Things now assume a somewhat different aspect. A man asked whether intellectuals and manual laborers would occupy the same status in the future Socialist society, and intimates that in his opinion that would not be fair. Thereupon we informed him, in as few words as possible, that he seemed to have forgotten the fundamental aim of Socialism, the abolition of social classes and class rule; that in a Socialist state of society everyone would have to do part of the work with certain requirements et forth in required in the social productive process; that no one would appropriate the fruit of other people's labor; that, therefore, no one would would consequently he free to develop his physical and intellectual faculties; and that, therefore, there will, under Socialism, be NO INTELLECTUALS AND NO MANUAL LABORERS.

is it possible that Ghent did not understand the reply as reabove? If so, we have somewhat amplified it now, so as to make it comprehensible even to him. But is it possible that this selfappointed champion of the intellectuals is so ignorant of the elementary truths of Socialism and so dense of comprehension? Shall we ascribe his garbled quotation, consisting of the FIRST PART of a sentence containing altogether eleven words, to a motive which it is impossible to characterise within the limits of parliamentary language? And was it due to this motive that Ghent waited nearly four months before calling attention to this "repulsive and disgusting notion"?

We do not know. But we know this, that the martyr's pose assumed by Ghent in his desperate fight on behalf of the intellectuals within the Socialist party is as false as was his quotation.

No sensible man in the Socialist party, and particularly here in the East, is opposed to men of superior education, knowledge and ability. On the contrary, the great majority of the working men and women who compose the bulk of the party are so distrustful of their own abilities and so anxious to secure the aid of educated men, that they only too readily assign the most important offices within the gift of the party to these supposedly superior men, who only too often are very ignorant men. But some of the intellectuals, as they call themselves, have not always proved worthy of their trust. In executive ability several of them have turned out to be inferior to the average workingman. Several of them have utilized their prominence in the party for the advancement of private schemes or for obtaining a standing in circles hostile to our movement. Others we shown a contempt for the opinions of the rank and file and a tendency toward influencing the party, not through free and open ion in meetings and press, but through secret agreem

It is these manifestations that are being resented by sensible "intellectuals" as well as sensible "proletarians." And the resent nt cannot be stopped by any amount of offensive characterisation to whose views one happens to be opposed. But it will cease as soon as the ground for it shall have disappeared.

This was a revolutionary doctrine, and immediately the opponents of Louis Blane saw the necessity of dis-

redi ing that doctrine. They opposed his views until they aw that opposition only hurt them. They then changed their tactics, and enthusiastically supported Blanc. That was the beginning of his ruin.

The people demanded the carrying out of Louis Blanc's plans, and certain destruction faced those who opposed

Immediately the enemies of Louis Blanc organized great national work-shops. And did it in such a manner to insure their failure.

Determined to discredit and paralyze the plans of Louis Blanc the state es ablished a military organization collected the workers into brigades

Tailors were forced to dig ditches, and ditchers to cut clothes; bakers to lay bricks and bricklayers to bake bread, until all ended in chaes and disaster.

That is, of course, what happens in every town where the opponents of Socialism are forced to undertake Hating collective activity, despising

the aims of Socallists the old party grafters almost invariably seek to make a failure of collective effort and to discred't that doctrine.

It is possible perhaps to force some municipal ownership and to have it in some instances fairly tried, but nat-urally it will never receive an honest trial until those people who believe in it conduct the trial.

When they tell you that Socialism failed in Paris in 1848 it only means that a form of state Socialism was made to fail by its enemies. It will fall again in 1916 or 1920, if it rests with its opponents to make the experiment.

A number of people in New York plan to form a large organization, for the purpose of operating a co-operative bakery, with a membership drawn from every part of the city. To become a member, a man must comply the constitution, and he must buy a share of stock. These people intend lower East Side. They intend to pay a dividend on the amount conumed. I believe they intend to have their employes share in the profit. So far, so good. I have no fault to find plan; it is with the manner n which they intend to pay their dividends that I find fault. They intend to issue slips or certificates, which are given with every loaf of bread which is sold. These certificates are returned to the society every six or three months, and the dividends on the amount consumed are declared or

My first objection to the above is that this system of distributing slips cuts off the principal advantage of true co-operation, stability.
