United States' Action in Nicaragua Case May Encourage Other Revolutionists.

WASHINGTON, Dec. 3 - Dispatche from Mexico City today indicated that the Mexican government was not in accord with the attitude of the United States in handling the present situation in Central America. The action of the United States, the dispatches said, was a surprise to the officers of the Mexican government.

It has become evident that Secretary Knox's note to Senor Rodrigues, the charge d'affaires of Nicaragua here, in which he outlined the Central American policy of the new administration, has caused considerable unrest among the Latin American section of the Diplomatic Corps. While they are chary of comm the action of Secretary Knox, they feel that his policy will furnish a bad precedent and will encourage revolutionists in attempting to over throw existing governments

The State Department has communicated with Juan J. Estrada, pres dent of the provisional government at Bluefields. Through Thomas P. Moffat, American consul at Bluefields, Secretary Knox has served notice on Senor Estrada that the provisional government will be held resp the security of Americans in his territory.



The ratio in which the income of the capitalis class as a whole is divided varies continually under many influence Census statistics for 1890-1900 indicate that about one-fifth of the capitalist income from the manufacturing industries in the United States was reinvested in those industries; besides this, a considerable amount was undoubtedly invested in commercial, financial, railway, mining, and other enterprises in the United States, and another portion in capitalist enterprises of various kinds in more ward countries—Mexico, South America, Russia, China, etc.

to reinvest too much of their income, the rate of return on capital falls bnormally and discourages further investment; when they tend to reinvest too little, the rate of return rises and encourages more liberal investment. Thus the accumulation of capital regulates itself in proportion to the opportunities presented by technical and social developments in such a manner as to give the capi-talists the largest possible share of

Organization of Capitalist Owner ship.—In the beginning, capitalist property was individual property in the full sense, implying also individual control. A COUNTRY-WIDE FIGHT.

The appeal, petition, or protest of the striking shirt waist makers to Mayor McClellan against the insults, intimidation, and abuses to which they have been subjected by the police, is a part of the fight now being waged in various parts of the country, in this city as well as in Spokane, against police brutality as well as against court inter-

Formally this is a fight for free speech, free press, and freedom of assemblage. Actually it is part of the world-wide fight between capital and labor

The fight for the preservation of the above-mentioned constitutional rights is in effect a fight for the extension of these rights to the working class.

In their origin these rights were conquered by the middle class in its struggles against feudalism and absolutism. When they were incorporated in the Constitution of the United States they were designed to be the rights of equals, property owners. That these rights would come to be used by a new class, the wage workers, in its struggles for betterment and advancement, could not of course have been imagined either by the champions of the middle class or by the framers of the "Bill of Rights" in the United States Constitution.

It is for this reason that the powers that be resist so stubbornly the employment of these fundamental constitutional rights so as to serve the ends of the working class. The rights which were natural and fundamental to a society of equals, of property owners, become violations of social order when employed by non-equals, the propertyless wage workers.

This is one of the contradictions that inevitably arise in the course of its historical evolution within the society based upon the equality of property owners. Just as the concept of property itself undergoes a transformation from individually earned private property into socially produced property controlled by collective bodiescompanies and trusts, so the concept of freedom and constitutional right undergoes a change, and that which had formerly been considered as fundamental to the existing order, now comes to be regarded as subversive of it.

The conquest of these rights to the uses of the working class is a necessary step in the advance of this class from a condition in which it was a socially negligible quantity to that condition in which it will attain to rulership over society.

UNCOMMON CANDOR.

Why, he even dared to suggest the horrible notion that the administration of law in this city is not superior to French methods of justice, upon which every true Anglo-Saxon is taught to look with contempt as the product of the inferior Latin race.

THE BIG STICK IN LATIN AMERICA.



had plenty of detractors. There were many in the various sections of the chaotic working class movement of that time who suspected him of harboring evil designs upon the move ment and seeking to advance himself over the bent backs of the workers. These often attacked him with great bitterness, especially when his keen relentless logic exposed the weakesses and shortcomings of the methods they were pursuing. But those who knew him best, who came into closest contact with him and felt his personal influence, were his most ardent admirers; those trusted Marx and his judgment most who knew him

During 1848-1844, Marx, who was at the time in Paris, had definitely allied himself with the Socialist cause as we now know it. He did not call himself a Socialist, however. The reason for this can be read in the intro-duction to the "Communist Mani-festo," written by Engels, to be found in practically every modern edition of the famous pamphlet. By Socialism was meant, at that time, Saint-Simon-ianism. Fourierism and Owenism was meant, at that time. Saint-Simonianism, Fourierism and Owenism-Utopianism in general. Marx accepted much of Saint-Simon thought, and not a little of Fourier's, but he also rejected so much that was fundamental to both, that he could not well have been called a Socialist in the then current meaning of the word.

So, to avoid confusion, Marx chose to call himself a Communist—hence the title of the manifesto. In the great whirlists of time the meanings of these terms have become practically reversed; we speak today of Marx in a Socialist, and of the others as being Communists, more or less.

As soon as he had definitely decided which part of the democratic

cided which part of the democratic movement he would identify himself movement he would identify himself with, Marx began to urge upon the leaders of the movement in Paris the need of an attempt to bring all the scattered elements together into one great homogeneous political and economic movement. Much of his time was spent in discussing this idea.

"What is your program, friend Marx?" he was constantly asked in those days, and his answer was not often regarded with much favor. As a matter of fact, he had no program to offer. He was, I think, rather indifferent to programs then; all he cared for was the movement. So that ared for was the movement. So that there was a live movement program mattered nothing at all. He had a platform rather than a program; it was simply "The working class must
