Rising of Rivers Causes Suffering

ST, LOUIS, Mo., April 4 .- Forecast ed rises from Hannibal to Grafton in the Mississippi and in the Missouri a short distance below Kansas City further rise in the Missouri from Glas-gow to Herman, foretell more trouble for the flood-smitten cities below. The Mississippi here registered 30.5 to-night, and is expected to go to 31 before morning, when a temporary



### TAFT WANTS TO SAVE BY REDUCING FORCE

Suggests Speeding Up and Elimination as Means of \$11,000,000 Economy.

WASHINGTON. April 4.—President Taft today sent to Congress his second message of the present year on economy and efficiency in the government service. He recommended the passage of legislation designed to save more than \$11,000,000 annually, in most cases by reducing the number of employes, and by speeding up. Probably his two most striking proposals were that the local government offices in the Treasury, Postoffice, Justice, Interior, and Commerce and Labor departments be placed in the classified service, and that the revenue cutter service be consolidated with the lighthouse service in the Department of Commerce and Labor.

By the first change, the President said, Congress could effect a saving of at least \$10,000,000 annually, and although in this message he gave no figures for the consolidation of the two services of the Bea, in a previous message on the same subject early in the year he predicted economies totaling about \$1,000,000 vearly.

The President concluded his message with an appeal to Congress to appropriate the \$200,000 necessary to support the Economy Efficiency Commission for another year, with \$50,000 additional for the publication of the commission's findings.

The principal recommendations for economics were as follows:

Placing of pension agents in classified service: estimated saving \$62,000, Abolition of office of receiver of district land offices and transfer of dutles to register, assisted by bonded clerk; estimated saving \$200,000.

Transfer of "political appointees" in internal revenue and customs services to classified service; estimate of saving not given.

Consolidation of lighthouse and life saving service into Bureau of Light-

### BILL GIVES SCALPED WOMAN \$4,200 MORE

### Senate Increases Appropriation for Injured Census Bureau Clerk.

WASHINGTON, April 4.—The Sensete today devoted most of the session to the consideration of a bill for the relief of Miss Alice V. Houghton, formerly a clerk in the Census Bureau, who met with an accident a year ago by which her scalp was torn off and other injuries inflicted by coming in contact with a tabulating machine.

Her condition was critical for several weeks, and she is still under treatment. The peculiar nature of her injuries aroused wide attention and sympathy. Her seelp has been restored through grafting, but she is still suffering from percousies produced by the shock. The special session of Congress appropriated \$1,900 to pay the doctor's bill and other expenses and to reimburse her for the loss of salary.

Today this appropriation was increased by adding \$4,200, which will be paid to her in installments of \$50 per month. The debate today was as to the amount that should be allowed for the injuries. Senator Crawford, of South Dakota, chairman of the Claims Committee, suggested that Miss Houghton's appearance would not suffer as a result of the injuries because the liberal appropriation would enable her to buy the handsomest wig.

Senator Martine, of New Jersey, thought Senator Crawford's remarks inappropriate and out of place. He suggested that the South Dakotan hasten to withdraw his remarks about the wig before the record was printed. He declared that a lady might have a glass eye or a cork leg, but insisted that the discussion of such physical infirmities was unworthy of the dignity and humanity of the United States Senate. ### TIMES' AMUNDSEN STORY NOT NEWS NOW

Applications of the New York Times for injunctions to restrain the publishers of the World, the American, the Press, and the Sun from printing accounts of Captain Anundsen's discovery of the South Pole were denied yesterday by Judge Lacombe in the United States District Court. Orders to show cause why these motions should not be granted were signed by a District Court judge on the evening of March 8, and the applications came on for hearing on March 29.

James M. Beck, for the Sun, argued that the Sun's version of Captain Amundsen's discovery was neither in fact nor colorably a violation of the Times' alleged copyright: that the Times had acted prematurely in starting a proceeding to restrain the Sun from infringing a copyright not yet obtained, and that there was no reason now for granting an injunction which would restrain the Sun from printing an injunction which would restrain the Sun from printing an injunction which would restrain the Sun from printing as story which had ceased to be news. On this last point Judge Lacombe based his denial.

The exact date of its composition is neg known, but it was probably written in the early months of 1723. The text treats of the betrayal of Jesus by Judas; Peter's denial; the scene with Pilate; the cries of the Jews for the crucifision; the agony of the cross, and the final requiem. The chorales are in Bach's most exquisite style, and the arias are among the finest he ever wrote. The choruses are in turn descriptive, dramatic and majestic in the extreme.
