The locomotive which exploded belonged to a subsidiary of the Southern Pacific. The report fited today gives the opinion of the inspector that the rules governing inspection of locomotive beliefs were disregarded by the railway company's inspector and that the steam gauge was not properly tested. It is asserted that an incompetent employe had charge of preparing the engine for service.

When the explosion occurred the officials and papers owned by the company tried to lay it at the door of the unions which have been on strike for several months.

Since the strike of the shopmen on the Southern Pacific the company has employed a lot of incompetent mechanics to do the work of the skilled strikers. The officials of the union predicted that the scale incompetency would endanger thives of the patrons of the road and the report made by the chief boiler inspecto corroborates the predictions of the strikers.

A TRUE UNITY CONVENTION

Since the organization of the Socialist party the members have recognized the fact that their position is in the forefront of the great class struggle, that they occupy the most exposed positions and that they must fight, and ever fight harder.

In Indianapolis the vote of the delegates represented not only men but women also. There were women delegates with as much power as that possessed by the men. Never before in the history of a growing, mighty political party has this occurred. What they did shows that men and women, working politically together, can achieve more for the benefit of humanity than any sex restricted party, no matter what its declarations may be. Furthermore, in the unfolding strength of the Socialist movement it is shown that woman is not a "contributing factor," but a necessary one. Much of what was accomplished at Indianapolis was due to our Socialist

When the matter of the indorsement of one or the other form of trade unions came up the delegates, almost to a unit, declared that the Socialists are ready to fight the battle of any group of workers. It has done so in the past. It will continue to do so.

Above all other organizations it has lined up, used its energies, gathered money, fought in all ways and at all times the following: Against the restriction of working class rights through the tyranny of the courts;

Against the use of the injunction for the purpose of hampering the workers when they rebelled against unjust conditions;

Against the utilization of the courts for capitalist class purposes For the political freedom of those who, driven from their own country, have sought asylum here:

And for the McKees Rocks strike, the Danbury Hatters' strike, the Baldwin Locomotive strike, the Philadelphia street car strike, the Lawrence strike.

The Socialists also led the fight in the McNamara case, and they have no apologies to offer for doing it. Though the challenge, "Let him who is without sin cast the first stone," despite its origin, is a villainous one and has covered many an unsavory affair, the Socialists did not and do not resort to it. They went into the McNamara affair in the belief that the accused men were innocent. They knew later that even though they were guilty the accused men were products of a vicious social system. So, when the dramatic confession came, there was no shock. The McNamaras were not Socialists. They were products and victims of capitalism. And for such we have fought many times. We not only desire to rescue such men, but we seek also to prevent them from being produced.

In this way fundamentally we differ from all other organiza-

And if any other men, charged as the McNamaras were charged, were to come before the courts today, we would without hesitation and with all our resources fight the ease out to the limit.

We could not do that if the party, as an organization, was committed to one form of unionism. When the Socialist party was organized it faced no great problems in the union field. During its career it has faced many-and it successfully met all of them.

Taking the latest instance it will be found that through the enthusiasm, the willingness and the self-sacrifice of the Socialists, the Lawrence strikers were financially enabled to put up their magnificent struggle. It was the Socialist party that actually fur-

nished the money for that strike and that gave it form and coherence.

Tomorrow an American Federation of Labor union, battling against equally inhuman conditions, may be on strike. Shall the Socialist party be in a condition where it cannot respond to working class demands without violating all its principles?

We are a political organization, always in the field, always ready to assist, always willing to help. We always have helped, and the Russian refugees, tens of thousands of strikers in widely diversified industries and belonging to various organizations which are supposedly antagonistic, the fighters for woman suffrage and

Our delegates in Indianapolis, not only during the proceedings but long before it, heard all the arguments in the case. They acted deliberately and according to sound working class principles. Every honest fight of any workers is the fight of all workers. Socialists cannot put a label on those who conduct the fight.
