VANDERBILT IN POLITICS.

The Why of the Wherefore of His Appearance in the Republican Convention.

Benjamin B. Odell, Jr., Republican Candidate for Governor a Vanderbilt Tool Lobbyist.

A Portion of the Record of His Services to Vanderbilt and Kindred Interests-Manipulator of Legislatures, Laws and Public Powers in General-Minority Stockholders Sandbagged and Robbed by the Power of Odell Made Laws.

The presence of young Cornelius Van-derbilt as a delegate to the Republican follows: State convention which nominated Ben-jamin B. Odell, Jr., for Governor, recalls in a striking manner the conspicuous services which Mr. Odell and his lobby have rendered the Vanderbilt family and their vast railroad interests in the ous Legislatures which the Republican

machine has controlled.
Mr. Odell, through Senator Timothy Elisworth and the other devotees of Mr. Platt, have constantly been on guard at Albany to further the great financial schemes of the Vanderbilts and New York railroads by special legislation, or by the restriction of measures calculated to embarrass their gigantic plans. It would be impossible in an article as limited as this must be to enumerate all of the special services which Mr. Odell has rendered the money kings of Wall street, especially the Vanderbilts' and kindred interests. Those which have been brought most directly before the public, however, and which have been more far-reaching in their consequences to the stockhoiders of the Yanderbilt companies, both minority as well as majority, have been the special acts passed in furtherance of the acquirement by the New York Central Railroad of the Lake Shore and Michigan Railroad and the Michigan Central Railroad systems.

These were Section 24 of the Stock Corporation law, which ren-These were Section 24 of dered the directors of railways and cor-porations personally liable for unauthor-ized debts and over issues of bonds, and forbade a railroad company to incur debt in excess of its capital stock, except when the capital stock is secured by a first mortgage lien. The second was sub-division of Section 4 of the existing Railroad law, which prohibited the di-rectors of railway companies from borrowing money or issuing mortgages without the consent of the State Railway Commission, and, in special instances, without the authorization of the Legisla-Commission, and, in special instances, without the authorization of the Legislature. To the Messrs, Vanderbilt, however, no legislative obstacles are insurmountable. The New York Central lobby, headed by Benjamin B. Odell, Jr., has never allowed such obstacles to pre-vail. Mr. Vanderbilt sent for Mr. Odell and outlined the situation to him. The plan by which the Messrs, Vanderbilt contemplated the absorption of the Lake Shore Railroad was clearly in defiance of this law. By the terms of the proposed deal, which has since been successfully carried out, the New York Central Railroad was to issue collateral trust gold bonds for \$100,000,000 exists. Central Railroad was to issue collateral trust gold bonds for \$100,000,000 which bonds were to be delivered to the stock-holders of the Lake Shore Railroad, on a basis of 2 bonds for one share of the stock; the capital stock of the absorbed railroad being \$50,000,000.

To repeal section 24 of the corporation-law would have caused an outery which would have perhaps been more powerful than even the lobby of Benjamin B. Odell. Again, the craftiness of Senator Elisworth was called into play. The third house had a caucus at which Mr. Elisworth outlined his plans to Mr. Odell. The repeal of section 24 would have been The repeal of section 24 would have to a maladroit measure, according to Ellsworth, while an apparently harm-less amendment, composed of a few words, exempting steam railroads from the operations of section 24 of the cor-poration law, would attract no atten-tion and would probably not be under-stood by two-thirds of the members of the Legislature, who would be whipped into line for the deal. Therefore the amendment of the law was drawn and massed both houses before they understood Ellsworth while on apparently harm passed both houses before they understood its significance. The press of this city, however, detected its great importance, and in a series of articles pointing out the great hazard in which the rights of the great hazard in which the rights of stockholders would be placed by such a measure, endeavored to induce Gover-nor Black to withhold his signature. Governor Black was himself personally opposed to the signing of the bill, he saw its great injustice to stockholders, and how far reaching might be its conse how far reaching might be its consequences to those who held the securities of the corporation. Again Benjamin B. Odell's influence was brought to bear. After holding out for several weeks, the Governor yielded to the arguments of the great lobbyist, and signed the bill, making it possible for the Messrs. Vanderbilt to override the wishes of a minority of the stock-holders, and to saddle as men's met. holders and to saddle as many mort-gaged obligations upon their railroad

Upon the surface the proposition of Messrs. Vanderbilt to give two of the collateral trust bonds of the New York Central yielding three and a half per cent each for one share of the Lake Shore Railroad, paying dividends of six per cent annually was attractive enough but, underlying the whole scheme, was a dishonestty of purpose which was not to be concealed even from the less as-tute portion of the minority of stockholders. COLORADO WAGE SLAVERY.

INDUSTRIAL CONDITIONS IN THE CEN-TENNIAL STATE

Amid Vast and Varied Natural Resources the Worker Wears Out a Miserable Existence-A Summer in a Sawmill Camp.

RICO, Colo., Oct, 7 .- Colorado with her Cripple Creek gold mines, with her Leadville, Silverton, Ourar, Telluride, Ophir, Rico, and numerous other silver and gold mining camps, with her vast valleys utilizing the waters from the mountain streams in irrigating farm and orchard lands making crop failures from drouth impossible; with her smelting in plants at Durayo, Pueblo, Denver, Leadville and Silverton; with her numerous sawmills devastating the mountain-sides and canyons of their timber covering. Colorado with her vast and varied natura! resources for producing wealth by the hand of the laboring class is as charming a wage slave paradise for the capitalist class as any of her sister states. True, the Colorado wage slave receives a little higher wage in compensation for his slavery, but it all goes back to the capitalist class in payment for food, raiment and the poor "comforts of life" vouchsafed the wage slave who in the sweat of his brow produces wealth for his capitalist task masters.

For underground labor in the gold, silver and iron mines the Colorado wage slave is given \$2.50 to \$3 for eight hours labor, with board placed at 90 cents and one dellar a day. Above ground labor at these mines is generally the same wages, but for ten hours labor, as the mines are situated at high attitudes, from 6,000 feet to 12,000 feet above sea level, with freight and passenger tariff on the railroads and stage lines as high as the altitude. from six to ten cents a mile. the wage slave engaged in mining needs must labor constantly, Sunday as well as week-day, to keep the grim wolf, want, from gnawing at his and his loved ones vitals.

The coal mine wage slave of Colorado is a slave indeed, a full brother to his mate of Illinois or Pennsylvania, paid a mere pittance for his wealth production with the pluck-me company store at which to purchase his provisions, if a man of family, and the stere and boarding house, if a single man, to benevolently assimilate the bulk of his wages or give way to others of his class who are willing to give back to their capitalist class masters all but what the grim wolf

The wage slave at the smelters are subjected to poisonous fumes from the smelting ores, labor ten and twelve hours a day with compensation little above the common day laborer, and when the last state legislature, through the pressure brought to bear on the capitalist class politicians by pure and simple labor unions, enacted an eight-hour day law, health measure protecting workers underground and in smelters, a republican supreme court judge, a democratic supreme court judge, and a demo-pop fusion supreme court judge, elected by the ballot of pure and simple union labor voters, united in an "unanimous opin that the act was unconstitutional; so the smelter slave labors on and is poisoned ten and twelve hours a day, creating wealth for smelter trust stock owners who never have seen the site upon which the smelter plants are

Each industry in which the wage slave is engaged in producing wealth for capitalist class masters furnishes a pen picture of the clas unconsciounes of the great majority of the laboring clas of this commonwealth, and as an illustration ber industry at the sawmill camps is one picture from the panorama of life of the wage slave of Colorado.

The writer, being a wage slave, has power, that is the choice of masters and, when in the early days of dune ,h came to the conclusion that he must sell, his labor-power for the summer months, at least, to some capitalist class muster, either to labor ona rally ranch or with pick and shovel scratch for a contractor on a sewer sys tem of the municipality where he was residing, each in the broiling heat of a summer's sun or betake himself to the mountains and seek employment in mine or mill where "Old Sol" is not quite so liberal in shedding his beneficent rays. The wage slave decided on mountain scenery, and, in past years having been accorded the distinction of being a firstclass sawmill hand, quite naturally de cided to burnish up his past record a season's labor at his old slavery. so happened that in his choice of capital ist class masters he chose a minister of the gospel, who, after successfully ex pounding the gospel, raising "taters" and selling them—the taters—at five cents a pound in the mining camps in sea-sons of scarcity, accumulating "a stake," abandoned taler culture for the lumbe industry on the preserves of Uncle Sam. The picture the writer now attempts to portray is not an exaggerated one of wage-slave conditions at the Colorado saw mill camps.

mill at which the writer is passing his "summer's outing" is situated near the Lezzard Head Pass on the line of the Rio Grande Southern Railroad, and is 10,000 feet above sea levels, an al-titude at which many find it impossible to labor and which draws heavily upor the nervous systems of all. Saw mill work is not of that class of labor, the textile mill, factory operative, machine shop employee, farm or ranch hand shop employee, farm or ranch hand supply only what yields them a profit in is accustomed to, but is one of constant, harmony with their social system plus pushing activity from the moment the the altitude.

mill starts at 76 clock until the noon hour and from 1 o'clock until 6 o'clock The logs are rolling in at one ond of the mill and coming out lumber at the other end to be rushed to the drying yard and piled according to length width and quality, not by the capitalist class master, but by his wage-slaves.

In front of the darge circular say stands the sawyer or leverman, himself a wage-sive, with lever, which is attach-ed to the throttle of the steam engines. Upon the increasing activity of this wage-slave depends the amount of lumber turned out daily, consequently he is paid a higher wage than his fellow worker, and, in order to hold his pos-ition, earn his wage and make a record as a sawyer or leverman, rushes the mill and slaves to the utmost. The logs are rolled upon the carriage which with feed is rushed against the saw the cut falls upon rollers and is hur riedly pushed to the edger table where hurriedly thrown order to be back at the in time to catch the next falling cut from the log. The cut is grabbed by the edgerman, hurriedly thrown upon edger. vitation to call at the office, where the apitalist-class master presents the taket-easy slave with a check on a bank situated at a good distance from the mill, which, in order to get cashed, the slave must give up from twenty-five to fiftey cents for bank exchange. Yet there are banks within twenty miles of he mill at which no exchange would be demanded.

The profit the mill owner secures off labor of his wage slave through his capital of saw mill machinery is not the only rake off our capitalist-class master enjoys, for he runs a boarding bouse and a commissary store "for the accommodation of his help...

When hired the writer was told that the wages paid was \$2.25 a day, with board at \$5 a week. In case of idleness the wages stopped, but the board account went on. The writer soon learned count went on. The writer soon learned that a number of wage slaves, who filled places in the mill that required knowledge of the labor performed and quick action, was being paid \$2.50 a day, and having been placed in one of those positions he visited the office and mildly asked if he could secure a raise to that figure, and received the promise that it should be. At the end of the month the increase in wages was allowed, but the wage slave found that his board had been raised also from the \$5 a week rate to twenty-five cents a week more, while his fellow wage slaves laboring at \$2.25 a day paid the \$5 rate, all eating at the same table and served the same "grub." A most glorious teaching of the Carpenter of Nazareth by our ministerial capitalist class, is it not?

The commissary or store is supplied with working gloves and mittens, which the slave must have in order to handle the lumber, with overalls, jumpers, common work-day shirts, heavy shoes, to-bacco, etc.; also provisions for his cook house and the accommodation of his log contractor, who runs a cook house in the woods. Gloves and mittens in the woods. Gloves and mittens that cost the writer one dollar and are sold the wage slave for one dollar and seventy-five cents, shirts that costs sixty-five cents are retailed at one dollar, other supplies that the wage slave must have corresponding prices to fit in with the altitude and assure an additional profit Our ministerial mill owner is a most

ardent expounder of prohibition doctrines, and most bitterly opposed to gambling; that is, if the wage slave drinks, in his sermons and temperance talk, but in his mill business his practices are different -just a little different-for this year at also foreman, that is addicted to lushing and gambling; in fact, quite a sporty character, who on several occasions has taken other wage slave mill hands off to ing, returning to the mill camp in a most Milarious condition, kicking in the door to one of the bunk houses, and "shooting up the house" with a six shooter, and supplying the boys with the Oh,-be-joyful from several bottles brought in their pockets. The following morning the wage slave who runs the engine was so paralyzed drunk that the mill had to shut down; there was no discharges followed, the head sawyer being a pusher, disposed to push every fellow wage slave to his utmost during work days is an essential factor in the economic production of lumber under our capitalist class sysfem, while the common help that tooted it with the head sawyer are wage slaves that keep an account at the commissary spend their cash lushing, and being con

sequently in debt, and needs must werk on making no complaint over board, com-missary charges or low wages. The wage slave conditions at this saw mill are no more intense than at others, for within a few miles of this mill camp are two other camps; at each the mill is run about half time, the logging teams not bringing in a sufficient supply of logs to keep the saw running stendily. Days when the mills run the wage slaves are worked to their utmost capacity: then lay idle, pay board as jong as they will stand the mill proprietor's racket, when they quif packing their bedding away on their backs, their wages having been absorbed by board and commissary accounts.

In the mills and most of the mines and ranches the wage slaves of Colorado must furnish bed and bedding, take the cold; cold ground for a couch, or sponge sleep-ing accommodations from his fellow wage slaves. Their capitalist class masters supply only what yields them a profit in

IN PITTSBURG

THE BUZZARDS' ROOST COMPOSED OF LABOR FAKIRS.

Examples of How the Leaders of Organ ized Scabbing Play Into the Hands of the Capitalists-The S. L. P. and the S. T. & L. A. Smashing the Gang.

PITTSBURG, Pa., Oct. 6.-Perhaps is a little late now to discourse about Labor Day, yet the subject of fakirdom is always an open target and so I intend to take a shot at them whenever I choose to do so.

We have in Pittsburg a buzzard's roost; some people call it the Labor League of Western Pennsylvania. The Labor Fakirs League of Western Pennsylvania describes it better. This league is composed of a bunch of cheap brainless intellectual misfits whom some people style "labor leaders," that is when they lead labor it is invariably into a capitalisht mantrap.

Individually and collectively they are labor Judases. Many of them live as objects of charity upon the toil and hardships of the poor unclassconscious dupes whom they trade upon, betray, and misrepresent. Their hardest work is to whitewash each other and patch up each others' characters. This being done, they resolve themselves into a mutual admiration society, blow off great volumes of wind about "the rights of labor," the "interests of the capitalist and laborer are identical," "no politics in the union "the bosses share. the aristocracy labor, etc., etc.," ad libitum, ad fakirdom, ad fooldom.

This zoological garden undertook pull off a labor day demonstration in the shape of a parade from the centre of the city out to Schenley Park, and ending up with speeches and fireworks. The capitalist newspapers stated that one of the set pieces of fireworks would show two hands clasped underneath the inscription "Capital and Labor." Who would have ever thought that your labor fakir was such a joker.

The capitalist newspapers were used to advertise and puff the affair in advance to quite an extent, and they annonneed with a great flourish that less than 20,000 or 25,000 men would be in line. The actual number of men in line was less than 2,5001 fakirs and al, and that, too, in Pittsburg, the great industrial center, the home of 350,000 working people, the headquarters of some fifteen or twenty national pure and simple trade unions. And yet after coaxing and bribing and threatening, its supposed following this was the best the buzzardd's roost could do in the shape of a Labor Day demonstration. Rats When organized labor undertakes an af fair of this kind it is generally supposed the purpose or object lesson is show their strength to the that show public; yet, in this case, they only succeeded in showing their public ; weakness, and I charge it against their faking crew that this attair was gotten up to deliberately expose and reveal to the capitalist class the weakness of the pure and simple trade unions both as to their numerical strength and as to their spirit of sondarity. And so frequently have such things happened under the "leadership" of the fakirs, that the capitalist either ignores the trade union or smiles in derision at it, or through its corrupt and ignorant fakir draughts it into his personal employ. Hence, we hear such men as Mark Hanna openly speaking of "My labor lieutenants." Mark might get a few "labor corporals" out of the buzzard's rost in Pittsburg, and they would never be missed.

The Chief Marchall (Chief Marshall is oo), was a fellow named Jones, a sort of an imitation Scotchman who understands the problems of Sociology about as thoroughly as a William goat All the fakirs rode on horses or in whom we expelled from the Socialist Labor Party. She, he or it, as usual wore the cylinder hat and the broad but too much working fakirs hard working fakirs to get out and walk in parade, and they all looked fat and lazy and pretty, even if they

did not look intellectual.

They had listed quite a number of freaks, who were to appear and make speeches, but when the time came only one little measly fahir by the name of McMahon came to time to do the wind jamming business.

One noticeable feature of the parade was the fact that it was composed almost exclusively of building trades or trades that have so far accepted the domination of the trusts.

The 70,000 coal miners, the iron and steel workers, the various sorts of glassworkers, and the employees of all the worsers, and the employees of all the great trustified and corporate interests were conspicuous by their absence, evidently to busy fighting "capital with capital" (i. e. empty bellies), to bother about a little Labor Day demonstration. Schenley pork lies along the line of the Consolidated Traction Roard, the President of the Consolidated Traction Company is Chriss Magee, member of the State Leislature, partner in a non-union rolling mill, the Dick Croker of

Pittsburg, owns the City Councils and two newspapers, is the God of the dogwagon delegation, and has just as many Democratic lickspittles on his staff as Republican, including Jerry Dougherty. Schenley Park is run as an annex tothe Consolidated Traction Company. And the reason why the buzzards as-sembled at Schenley Park for the speeches, fireworks and all the other horseplay was because the Consolidated and a few other business concerns finenced the whole thing. And that is what your labor fakir in Pittsburg calls

a demonstration or celebration of La-borDay by organized labor.

Thanks be to the spirit of Carl Marx the time is not far distant when the So-cialist Labor Party and the Socialist Trade and Labor Alliance, the right and left arms of the working class, will

destroy this pure and simple absurdity and punish the labor Judas, as he richly deserves.

Labor unions will yet exist for many long years to come, but their value de pends on their basic principles. W must have a political party that is also a trades union, and a trade union that is also a political party. These we already have in the Socialist Labor Party and the Socialist Trade and Labor Alliance, the two arms of the working class body and they are all sufficient.

The once powerful glassworkers as ociation is all spraddled out and flaber gasted. Another pure and simple Noahs ark gone to what Mr. Mantillai called "the domination bow-wows. Under the leadership of Burns and a few more kindred buzzards the four trades are entirely divided and at daggers point. To hear the glassworkers talk and rail against each other one would imagine that they were born natural enemies instead of being really of one class whose interests are identical and who nust ither hang together or hang separately; the spirit of class solidarity is as absent among the glassworkers as it can well be. The capitalist combine using Burns

et al as tools has succeeded in arraying the workers into three hostile camps, one composed of the blowers and gatherers one composed of cutters, and another composed of flatteners. All plotting and scheming to accomulish with their own purposes at the expense of the other trades. All poesing as union men, any one of the three camps stand ready seab it or to get others to seab it on the other two, just as soon as they think they can do it with safety. Oh, the bitter shame of it all. Oh, the scoundrelism of Burns and others, who will yet hear from me, who have wrought this ruin, and brought this hamiliation to the working class.

It is rumored that an effort is about to be made to organize again under the auspices of the same old scab K. of L. What lunacy possesses these dunder-

heads, any way.

Even experience cannot teach some Your pure and simple trade s the Noah's ark of the labor people. movement, and filled with ancient and fossolized ideas and failures. It might just as well be undersetood that this ancient and obsolete craft cannot be caulked up and made to float and carry. who cherrish this idea and To those scheme as a pure and simple trade union of the old style, we say to you don't You cannot do it. You will only waste your time and money, go through the same old dreary routine of internecine strife, register another failure and make all around fools of yourselves. If you do not make such a study and investigation it is only one more proof of your ancient and conservative jackassa tiveness. Later on, whether you like it or do not like it, the S. T. and L. A will call for you, and you will come and be glad of the chance to come.

CHINA'S DEATH SENTENCE.

Her Doom Pronounced by Pcace Congress.

Those lovers of peace who have been optimistic enough to hope that China would not be dismembered and that the angel of peace would spread her wings over that unhappy country, will have to abandon all hope. The International Congress of Peace in Paris passed some resolutions on Oct. 3, which effectually snock out any chance of a peaceful set tlement.

The Congress resolved that the action of the missionaries was often intolerent; that their religious propaganda should not be backed up diplomatic or military force; that they should go into China at their risks and perils; that Europe should abandon any religious pro-tectorate in China; that forcible annexation of territory, especially that held sacred by the Chinese, should cease; that the powers should attempt to establish a stable native govern-ment, capable of undertaking internal reforms, and that the open-door for the honest commerce of the world on equal terms is the only policy which gives any guarantee for the country's future peace and stability.

In the light furnished by the camp fires of the British soldiery as they marched to the destruction of the Boer Republics, and the blaze Filipino villages where Yankee advance guards of civilization were "benevolently assimililating", the "rebels," the resolu assimilating the rebels, the resolu-tions of the last Peace Congress are seen to have meant something just a trifle different from what the simple outsiders supposed. So these resolutions must be taken in the Pickwickian sense. They mean this:

The christian missionaries are intoler ent; they must be backed up with maxim guns and military force; there must be religious protectorates established by atheist France, agnostic America, Salva tion-Army England, philosophical Ger many and pagan Russia; forcible annex ation and loot must be the motive; the temples and graves of the Chinese must e desecrated; internal deforms must be set on foot and a factory proletariat put to work competing with their white wage slave brothers; a slaughterhouse government combining Russian brutality with American and European bourgeois cunning must be established; the open-door—if it suits the stronger, if not, not.

If there be any who doubt this interpretation of the Peace Congress resolu-tions, let them read the resolutions of the Hague Congress and then glance at an up-to-date political map of the world as re-arranaged, sponged over and ironed by the nations who did the resoluting.

A Peace Congress to-day is the call to arms issued by the Nations to whom war is only a business enterprise of which the vanquished pays the losses and the victor takes the profits. The more brotherly love and yearning for Peace are expressed in the resolutions, all the more horrible and wide-spread will be the ensuing devastation.
Unfortunate China. The Doom is hov

ering near you. The Peace Congress has pronounced your death sentence.

LABOR FAKIRS PARADING VOTING CATTLE.

not the courage to discuss the trade

union question with us in public, a few remarks on the matter will not be out of place here. A trade union, or labor organization, is a combination of wageworkers formed for the purpose of fore-ing the capitalist to make more favorable terms with them. To accomplish this the capitalist must first be forced to surrender. Or as it is more commonly called, recognize the union. If the union fails to get recognition, then the capitalist alone dictates the terms of employ-ment. But if he surrenders, then the wageworkers have a voice in making those terms. The S. L. P. agrees with the pure and simple trade union that the he wageworkers as large a share of as possible. But upon the question of to force the capitalist to surrender. and what the attitude of the trade union should be towards the capitalist, it differs from trade unionism pure and and endorses the principle of the S. T. & L. A., which is based upon the principle that labor produces wealth, and that the capitalist in present stage of the economic system superfluens, as useless to the produ tion of wealth as a potato bug to the production of a potato crop; and when forced to surrender he should be treated as a parasite. To force him to surrender, the wage-

worker should use his political power as well as the economic. Unions pure and simple, which are so-called because they are purely and simply economic, are hased upon the principle that the capi-talist as a necessity, and is entitled to live off of the labor of the wageworkers and should only be regulated by the trade union. In forcing the capitalist to surrender it uses the economic weaponsthe strike and boycott-alone and, although it is invariably met, and most always defeated with the political weapons, such as injunctions, jails, militia, etc., it fails to see the necessity of wresting this power from the capitalist, and persistently votes it into the possession of the capitalist class. The S. T. & L. A. holds that economics and politics can not be kept separate and consequently trains its members in that science by having a regular order of business for political discussions in its meetings, and it allows none of its officers or repre-sentatives to be affiliated with any capitalist party.

In conclusion, I wish to say to all wageworkers, who are satisfied and who are dissatisfied with present conditions, and who are continually raising the questions as to whether we are baying proser Republican times are better than Democratic times, that the Socialist Labor Party is not a silly reform party which quibbles over the extent of rights or wrongs, but a revolutionary move-ment which considers the principles of those rights and wrongs only. If you examine its membership you will find that it is composed of wageworkersmostly skilled mechanics who are receiving wages that are above the aver age of the wage class.

History tells us that while the patriots were fighting King George's taxation policies, King George, as a last resort, abolished all taxes except upon tea and thally gave the East India Tea Comto sell ten to the colonist with the three pence tax on cheaper than formerly with it off. But still the colonists were not satisfied, because they were fighting the principle of taxation and not the extending of it. So it is with the members of the Socialist Labor Party. Even if the capitalist should give us real prosperity his own expense to such an extent that we could all wear diamonds and self went in rags, we would still insist that the means of production and dis tribution in his possession and upon which our life depends, should be taken out of his hands, and placed in the hands of the whole people. Because, so long as these things are his property he holds the power to oppress us; how he uses that power does not affect the question. The thing to do is to strip him of the

The Vanderbilts knew this better than anyone else when they offered to exchange securities yielding seven per cent for stock whose yield for years had only been six per cent. At the least eleviation Lake Shore stock could yield eight per cent., and its statistical posifon in the New York stock market fully marranted this expectation.

A big block of the eight per cent Lake S ore stock which was to be snapped off for the seven per cent New York Central shares was held by influential Republicans in the western part of the State particularly in Chautanqua, Cattaragus, Allegheny and Eric counties. This great Republican section of the State made n vigorous protest to the railroad commission, to the governor, and do other representatives in the Legislaturn against the proposed spolistien of their rights which the first amendment to the railway law contemplated. The public, however, heard nothing of their protests. They were promptly suppressed by the Benjamin B. Odell lobby, and the protests sent to the legislatures were pushed aside by Mr. Odell without eren consideration, because the New York Central commanded that they be ig-nored. Then the Lake Shore holders in the western part of the State began to threaten personal suits against the directors of the corporations who were a party to the deal in which Lake Shore ecurities were depreciated in value.

A number of members of the assembly

from the western part of the State received scores of appeals from their constituents who owned Lake Shore stock, begging them for assistance in the legislature to prevent the consummation of the proposed Odell deal. This is a story of capitalist swindling in Connecticut. It is a tale of how workingmen are robbed, and of the des perate measures resorted to in order to prevent the truth from coming out. It punctures the theory of the "happy little home" for workingmen. It shows how red-handed robbery is practised with impunity on the working class as long as the capitalist class holds the political power. Read it, workingmen, and

Joseph Alsopp is a toolmaker. He has a wife and daughter depending on him. He has worked at his trade for the past twenty-five years. Wherever he has lived he has always been looked upon as an honest, hardworking mechanic whose one ambition in life has been to work long and hard for his loved ones He was a typical workingman in this he knew nothing of the law, for he heard nothing of it in the shops, and policeman had never placed a hand on his collar.

Two years ago, in pursuit of his employment, he came to Derby, Conn., and secured employment as toolmaker at the Driggs, Seabury, Gun Shop.

He looked around for a house to rent and found it impossible to get one. He was informed that the Housatonic Water Company owned all the land worth mentioning in the town of Derby, and al gatuck rivers. He was then confronted with this proposition: EITHER BUY A HOUSE FROM THE HOUSATON IC WATER COMPANY AT THEIR TERMS, OR GO, WITH YOUR WIFE AND DAUGHTER, ON A TRAMP IN A STARVING CONDITION, TO EMPLOYMENT IN

Joseph Alsopp bought a house from the Housatonic Water Company and the capitalist politician pointed with pride to his "happy little home," patted him on the back and told him how easy was to become a property-owner in New England.

payable in instalments of \$20 a month plus interest at six per cent, water rates, insurance, etc.

Alsopp, after signing the contract with he Housatonic Water Company, kept his eyes epen and soon found out there was a beautiful swindle being worked on his shopmares and others by the cap italist powers that be in the Naugatuel

Valley. This is how it was worked: The land of the towns of Derby and Shelton and the rivers on whose banks these towns were built, were owned by a small clique of capit zlists. The Housetonic river was daismed and the water used for the motive newer of the differen factories that studded its banks. When a workingman settled down in either the towns of Shelton or Derby he was told if he desired to stay employed he had to become a property owner. All sorts of promises were made to him. He would he told that in the event of sickness lack of employment they would not bother him about payments, but they alway took care that nothing of that sort would appear in the contract. After the work ingman had paid on the house or lo as the case might be, for a year or eighteen menths, he would be laid off. No work was to be had in the town: whereupon he would go off to seek em ployment elsewhere. The mortgaged would be foreclosed, and every cent that new purchaser would be found. same lying promises, the same lies, and so the swindle was perennially repeated.

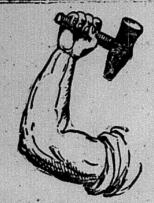

genuine trades unions. Our position is this. We are willing to light the battles of our class-But, we don't propose to fight them upon ground chosen by the enemy and swept by its guns. It makes no difference to us if the man who leads the workingmen's hosts to such a fatal spot is the capitalist who does so intentionally, or the pure and simpler who does so through ignorance.

THE SOCIALIST MOVEMENT IS NO GIDDY-HEADED ATALANTA.

In previous issues reference has been made to a recent book on economics issued by Prof. Richard T. Ely. Numerous errors, fallacies, icnoherencies that appear in it have been pointed out in hese columns and exposed. The book might be utilized as a veritable "vade mecum" to exemply sound reasoning by contrast with its procession of blunders, To a certain extent it has been utilizedthat way in these columns, and, as occassion offers may be put to still further use, later on, in the same line. However, before dismissing the book for the present, it is well to contemplate it in the "all together" and by the light of the large number of similar productions that the modern Social Question or Socialist with. Such contemplation will reveal an interesting sight.

The classic legend tells of Atalanta, a ravishing maid, of physical, yigor but light of head. She was a swift runner, and, of course, was beset with suitors. Her condition was to run a race; He who out-ran her should have her; he whom she out-ran was to be forthwith beheaded. The charms of the maid overcame the dangers of the courtship. Many applied, but only to lose their heads instead of winning her at the goal. She out-ran them all. Finally, one presented himself who had observed her closely, and concluded that, matchless in a fair race, she was conquerable by stratagem. The race started with him in the lead, but her vigor of sinew was such that she gained on him rapidly. When almost up to him, he dropped a glittering apple; the gay-looking thing fascinated her as it rolled off; she stooped to pick it up, lost time thereby, and he took a spurt forward. Again she began to close upon him; and again, at the right moment, he dropped an apple, which, again stooping to pick up, made her again lose time, enabling him to recover his lead. For the third time Atalanta had closed the distance between her and her running mate; the gool was now almost within reach; she was certain to pass him and touch it; but he had a third apple in reserve, which, rolling down, again, caught her eye, caused her to lose time in stooping for it, and gave Hippomenes the

The stratagem applied by Atalanta's successful suitor is the stratagem that the upholders of the present monstrous

social system of capitalism are seeking to bring into play against the Socialist Movement. A race is being run between the two. The inherent vigor of Socialism has enabled it to nearly close the distance that Capitalism first had the lead of, and to insure its triumph. At this stage, glittering apples are let drop in its path in the shape of "banale" economic literature. Like Atalanta, losing time in stooping to pick up the apples that Hippomenes tempted her with, Socialism is expected to lose time and fritter away its energies in tackling the hairsplitting arguments and involved sophistries that the intellectuals" are getting up to order so as to tempt it with.

But all of no avail. The Socialist Movement is no giddy-headed Atalanta. As solid in mind as in body, it can not be wheedled out of the direct forthright. With the goal steadily in sight, it will reserve all its energies to reach it, the complete overthrow of the latest and last sys tem of human enslavement-The Capitaiist System of Exploitation.

LISTEN TO THIS TALE OF OR-GANIZED SCABBERY,

A pamphlet entitled "Trusts," has just been issued by one D. F. Kennedy. Considering the season in which the pamphlet appears, and also its contents, the production is a transparent political document, inspired and paid for by the Republican party.

The pamphlet is intended to prove the beneficial features of the Trust. In order to do so the author does what all praise singers of wrong do, to wit, start in with partial truths, and thus, having insinuated falsehood, turn such insinuations into a bridge over which to carry outright and robust falsehood. The process succeeds with the unwary. It is as clever as it is dastardly.

That the Trust is in line with progress the Socialists alone have been able to make clear: it is essentially a contrivance of production; in its very concentrated form consists its excellency: the more concentrated capital is, all the greater is the productivity of Labor: consequently, all the larger is the wealth at the disposal of man. In so far, the Trust is beneficent. But that is not the whole truth.

Its great powers for good, consisting in its concentrated form, is not the only feature of the Trust. That feature is the system of private ownership by which it is held. This feature, it has been demonstrated, nullifies all the Trust's capabilities for good. Being owned by private concerns, it is operated for profit. This brings it wholly under the category of capital, that is to say, it causes the displacement of Labor; is increases the supply of Labor in the Labor market; thereby it reduces the price of labor-power, which means the wages of the workingmen. It creates abundance of poverty, at one end of the social scale, and congestion of wealth at the other.

In view of this, the Socialist Labor Party demands that the beneficent qualities of the Trust be preserved, but that it be stripped of its baneful qualities, to wit, its system of private ownership, This is the position of intelligent economics, sound sociology, and class conscious Labor.

But the old parties hold otherwise. The mule Democracy, affects to want the Trust smashed. If this program were, indeed, carried out it would be tatamount with throwing civilization back.

The Republican party, on the other proposes to keep the Trust just as it is. Accordingly, its campaign literature on the subject expatiates on all the good that there is in the Trusts, but is silent on all the mischief that the Trust in fact produces, and it goes further. After the suppression of vital truth, it makes headlong plunges in deliberate falsehood. The falsehood consists in forging figures to show that the TRUST RAISES WAGES.

That capitalists should talk this way is in the fitness of things. Now, is Mr. D. F. Kennedy, who indulges in such forged figures, a capitalist? Let him

"OUR NATIONAL LIFE."

Mayor Jones, Socialist and anti-Socialist, Democrat and anti-Democrat, Reformer and Corrupter, finds many things that "threaten our national life." All the issues of the Republican party, as a mater of fact, make these threats, and Layor Jones is out with his little hatchet in order to hew out a better civilization, a grander and more glorious future for humanity. He begins by joining the Democratic party, and extoling Bryan as the man to bring better and more glorious things to a suffering people.

The reputation of Mr. Jones bags slightly at the knees. There has never vet been a scoundrel cornered who did not wish with exceeding longing for a better social state. The one in which he lives is prone, sooner or later, to bring him to account. No mater which way he turns and twists the blow falls or him. In the case of Jones it was the hammer of the Socialist Labor Party that fell, and Jones, after resorting to all the old dodges, was forced to run to Bryanism for shelter. He has worthy company there, and more worthy mem bers will be added.

The last refuge of the mentally blind halt, and lame has more than its usual display of wares this year. All of the freaks, the canting impotents, and the broken down oratorical hirelings are up in arms fighting to save the country and to renel all those things which "threaten our national life."

Jones is among the ones who cannot sit idly by and see the national life threat ened. It is less than a year ago that he was accused of making such threats himself, but now he has recognised the errors of his way, and has joined his accusers, and is making common warfare against others who are "threatening our national life." When he started his campaign for the office of Governor of Ohio, he had a drift-wood platform. All the played-out issues were incorporated in it, and the voters were asked to support the candidate who stood on it because of a local myth to the effect that he was a man whose heart beat warmly for the working class. It was also asserted that he applied the golden rule, but where he applied, how he applied, and to whom he applied it were matters of no considera-

He wove a web of fine phrases around himself, and having attributed to himself almost superhuman graces, sought to win public office. The fact that he stood on a platform that was weakness personified did not matter. The fact that he had been a veritable political weathercock ready to point with any wind, no matter how tainted it might be, was of no consequence. The fact that he had protested and then threw all his protestations overboard was not considered. Now, after all these actions, after having made a donkey of himself, and a laughing stock of the workingmen who followed him, he comes out on the Democratic platform in order to appeal to the workingmen to support William Jennings Bryan.

Such men act in the capacity of political train-ditchers. They may not win the loot, but they can at least destroy the lives of the passengers. Jones, during the past few years, acted in that capacity in a local, and a state way. This year he goes in on a national scale. At first he saw things which threatened our city life. Then he saw things which threatened our state life. Now he sees things which "threaten our national line." He rises progressively, and his field of threats increases in proportion.

The Socialist Labor Party opposed him when he ran for Mayor, and posed as an independent Republican-whatever that means. We opposed him when he became violently reformatic, and ran for Governor of Ohio. Our reasons are made good this year when he allies himself with the party of reaction, and of political crookedness. , ,

We reproduce from the "Congregationalist" an article which correctly sizes up the scab who poses as "labor union leader." It describes his political career; how he cajoles the strikers into electing him, and how, after election:

Interesting and instructive as the ar ticle is, yet more instructive is the lesson its appearance in such a publication conveys. It is one of the fruits of that aggressive policy of the Socialist Labor Party which has exposed and denounced these misleaders of the working class so fearlessly that it has caused their actions to be scrutinized closely by even those outside of the Labor Movement. There can be but one result of such scrutiny. and the "Congregationalist" article embodies it.

How the capitalist helps the Scab to fasten himself on to the backs of the worker by collecting dues to keep the fakir's labor union (?) affoat, is told in the following passage in an account of the up-building of the United Mine Workers of America:

"The local president, for example, may say to the company that he desires it on the coming payday to withhold from each miner a certain sum which is to be applied to the expenses of the local. the miner protests he is threatened with expulsion from the order, and this is menace, which he cannot face. It means if carried out, that he will not only los his immediate employment, but that he will become an outcast in the bituminous

This evidence from non-Socialist sour es is valuable in that it shows the good effect of turning the search-light of truth on that Organized Scabbery which has masqueraded so long in the stolen livery of Unionism. To turn the light on these bats and drive them from the temple is work absolutely necessary to the upbuilding of that clean Unionism of the Socialist Trade and Labor Alliance, which will not permit the Scab political or otherwise, to find shelter within it.

The Socialist Trade and Labor Alliance spells death to the Scab whom the "Congregationalist" has so well sized up.

ENDING THE COAL STRIKE. Mark Hanna says:

'Any man who would put a straw in the way of a settlement of the great coal miners' strike now progressing in Pennsylvania should be taken out to the nearest lamp-post and hanged."-New York "Times."

But the man who provokes a strike? What should be done to him? Should he go free and unchecked? Should be be allowed to continue his career as a devastator, and as a causer of strikes?

There are more things bound up in the oal miners' strike than have played a part in any strike that has yet occurred n that region. As it develops we are conscious of this fact: both the Democratic and Republican parties are watch ing matters, and both are aftempting to take advantage of the strike. Both are anxious to profit by it. Both are in a large measure responsible for it. ONE IS NOW PREPARING TO MAKE CAPITAL OF IT. Hanna's words point to the party that is so preparing. It is the Republican party, and the exulting shout of glee is already rising. There is the list of dead and wounded there is the list of families that have beecn living on short rations during the past few weeks; there is the suffering caused. But will they not all be wiped out if the great Republican party steps in and "settles the strike?"

The majority of the operators are Republicans. All of the principal operators are capitalists who have advanced and developed far enough to understand the necessity to themselves of an absolute control of the coal output. A headline in the "Times" gives the clue to the

"Small operators angry: say they cannot advance the men's wages ten per cent. unless the railroads reduce their tolls."

We can give the "Times" credit for being the most consistent exponent of capitalism published in the country. It is not only consistent, but it really borders on superb effectiveness. But even in its columns the truth is often told if two articles are placed together. Drawing conclusio... from Hanna's article, and taking the "Times" news item, we have this: The small operators are being ruined by the strike; the Republican managers are going to settle the strike; and take the credit for it for campaign purposes. The conclusion is that there was a twofold object in causing the strike: to crush the small operators; to hold Pennsylvania in line for the Republican party.

Devious are the ways of capitalism in achieving its object. The capitalist class will do anything. It will stick at no crime. It will spare no expense. IT WILL EVEN ADVANCE WAGES IF IT CAN PROFIT BY IT. That is what it intends to do in the present instance, but not until it has gained its

Now the Republicans are preparing for a grant "settlement." The Republican mine owners caused the strike in the first place. They may be forced to grant a slight increase in pay. They will more than make that up in the vote which they receive, and above all in the fact that they are squeezing out the small operators. Should Hanna and his accomplices go unrebuked? Should they be allowed to continue unchecked in their actions? No! Vote for Malloney and Remmel and forever end this political jugglery, this pitting of the very life of the working class against the wealth of concentrated capitalism.

AN HONEST BRYANITE.

"What do I think about the Pennsylvania mining strike? Oh, the miners are a lot of ignorant, poor foreigners, who are brought over here to drive out honest American labor from the mines. Now they are kicking. But they were born miners, and they will die miners. They will stick right there till they die, and never go away to large opportunities, and so let competition in labor solve the question of the mine workers' wages.'

This is the utterance of Ben Tillman in a speech in Chicago a few days ago. Tillman is a United States Senator and an ardent Bryanite. He is noted for his brutal frankness. He has boasted time and again in public of stuffing ballot boxes and driving negro workmen away from the polls with shotguns. He can generally be relied on to brag openly of what the more astute Bryanite leaders try to conceal. He is the typical Southern bully, coarse and ignorant, the laborskinning "chevalier." He is a clown in politics, and clown-like, he tells the truth which the ring-masters would fain sup-

His contempt for the working class is shared by all the other leaders of his party, but policy forbids them showing it. Tillman's State is a veritable stronghold of Bryanism. The wage workers there are mostly negroes. Tillman boasts that they have been disfranchised with shotgun, and by a constitutional amendment.

Tillman regards the working class as fit only to be exploited; whether black or white, "niggers" in the South or "ignorant, poor foreigners" in Pennsylvania, they are "mud-sills," entitled to nothing except the right of being robbed. Tillman applauds the murder of the miners by his brother capitalists in Pennsylvania and his Democratic colleagues in Idaho. He approves openly. Bryan does the same thing, but like the charlatan he is, he does not give it open expression. Bryanism is Tillmanism with its blatant mouth shut.

The miners and every other worker in the United States should administer a slap to the yulgar faces of the Bryanites who starve, shoot and Bull Pen them in Idaho and then refer to those whom the Republicans are starving and shooting as "ignorant, poor foreigners" They should slap at the same time the faces of the McKinleyites who killed them at Hazleton and Homestead, and applaud the murders done by the Bryanites.

There is but one way of doing this. Vote for that Party which demands the lownfall of Capita ery. Bryanism and McKinleyism are only the political expression of capitalism. A vote for the Socialist Labor Party is a smashing blow at Bryan and Tillman, McKinley and Hanna.

To the DAILY PEOPLE-I have been reading so much in the DAILY PEOPLE about the buzz saw of the S. L. elected to office.

But when he takes his seat as the representative of labor he is a different man from what his constituents expected. He still talks for the laboring masses, he denounces capitalists. But privately he contrives to be the tool of the corporaenable him to continue in public life, without the necessity of visible employment or the risks of business.

Another case in point is that of a great be the fact that one of the highest leaders of the workingmen was hired by capitalists to lead the strike for the purpose of forcing down the stock of the corporation in order that these foreign speculators might buy it up at a great profit. This leader engineered the strike which was of exceptional severity, and secured the depression of the stock. The strike caused the discharge from employment of many of his fellow employ ees, who sacrificed themselves for the

As a consequence of his part in the transaction he has been able to live for several years since the event without dabbling in politics and figuring as a lobbyist in the employ of persons

unknown. Cases of other labor leaders might he mentioned who are in the movemut for their personal benefit, whether it s for the sake of the notoriety, or because the prominence will make them of so much more value for the corporations to buy off, or because they may find an entrance thereby into politics; with the sordid and criminal ways of accu-nulating money which inhere in the shady walks of this occupation. Usu-ally they are uneducated men, not familiar with either money or power,. The possession of a little of either or both at all. of these turns their heads and they beome false to their friends who elevated them to their responsible positions.
