A "Cop" stopped him, telling him he could sell his papers, but must not call. That is, if a customer happened

Wappenstein's appointment was a shock to many of Seattle's citizens and while a majority have recovered, many are yet wondering how it happened.

He got busy as soon as he was appointed without being told to hurry.

He ordered all prize fighters to leave town but overlooked a bunch of Surething, Double Cross Grafters, who had been running fake fights and wrestling matches in a house boat on Lake Washington for months, and who continued for months after Wap's appointment, and robbed people to the extent of two hundred thousand dollars, under Seattle's reform Mayor.

When the Seattle "Star" published the story about this gang of cut throats, Wappy said that he did not know that they were here.

We know better. Wappenstein knew this gang was working in September. 1905, and Mayor Moore does not dare to ask for the evidence of this fact and like the train spoken of by Mr. to be furnished to our city council.

Then the fact came to us throu the "Post-Intelligencer" that Wappenstein had made an arrangement whereby crime and Prostitution would pay the City of Seattle sixty thousand dollars per year.

What a glorious victory over crime by our moral giant, and known, supported and sanctioned by these Christian gentlemen of family!

Yes, the owners of the houses are to pay one-fifth of their rent into the city treasury and this together with the fines from prostitutes (which in Seattle is a crime licensed by our city administration) will net the city sixty thousand dollars per year.

But, said Wappenstein, in no case will the landlords be allowed to raise the rent because this would make the prostitutes steal. A valuable man to capitalists, is Wappy, because only a post graduate expert specialist could possess the qualification to inform us how much rent a wretched, shivering harlot could pay before she would steal.

## RTLAND PLATFO

We, the Socialists of the City of Portland, in convention assembled, do hereby reassert our adherence to the principles and program of International Revolutionary Socialism.

In view of the fact that the Working Class, by their intelligence, industry and skill, create every object of wealth in the world, yet are, through the private ownership of the tools and means of production and distribution, denied access to the very wealth which their own hands alone have created; and as we believe that the vesting of this power to withhold from the masses, by a powerful few, the surplus value which has been created by these masses, leaving them but a bare subsistence, is a privilege granted by a political force, the creature of these dominant few, the capitalist class; and as we further believe that this Class-Government, this private creature of the dominant few, of a necessity must become the public servant of the democratic whole:

Therefore we assert that the Socialists of the City of Portland enter the political field as a fraction of the International Socialist Movement which aspires to wrest from the capitalist class the powers of government and to use these powers in the interest of the Working Class.

Our aim in doing this is the abolition of all laws which vest in the individual the right to own privately what is needed for use by all.

In other words, the abolition of the wage system.

With this aim in view we place in the field a ticket which is composed of dues-paying members of the Socialist Party, all of whom must have been members of the party at least one year. We demand of them that they pledge themselves, if elected, to act in accordance with instructions from their party organization and not as individuals.

And so without any attempt to mislead any person we lay before the voters this declaration of our principles and aims. If you believe in the taking over of the tools and means

## THE MORAL **SQUAD**

#### By Thomas A. Sladden

(Rejected by the "Oregonian.") In the land of the free and the home of the knave, I see in "The Oregonian," that our so-called "Moral Squad" (?) are to be given still more latitude for the violation of one of the greatest principles of free government; the maintenance of the home inviolate.

We are told on every hand by statesmen innumerable that there are no classes in the United States, and that the rich and poor are equal before the law.

Dare any sane person maintain for a single instant, that this moral or immoral squad would be allowed to proceed into the wealthy district of this city and indiscriminately bundle the occupants of a house into a patrol and like a load of cattle dump them at the station, there to prove their respectability to the officer in charge, or if he felt so inclined, to lie in a lousy jail until they proved their innocence of any offence to the police judge?

Yet there is, perhaps, as much immorality concealed on the hills of Portland as in the valley.

The lodging houses of this city contain thousands and thousands of hon est toilers, they are their homes, the only ones they know and in many cases the only ones they ever will know. In Russia the Cossacks are forced to serve papers on people whom they suspect of having dangerous explosives in their possession. Here in Portland you send worse than Cossacks out, free to break into any place like a burglar in the night.

Suppose they went to the home of the Hon. Mayor of this city at say 12:00 or 1:00 o'clock in the morning, rang the bell, and when the mayor appeared, said, "I want you," clapped their hand on his shoulder and took him to a patrol box. When he wanted to know what he was arrested for he would be told the captain would tell him. When he got to the station he could explain where he was married, when, etc., or send a messenger boy to his bome for his marriage certificate, showing that he was entitled to be alive. Then he would be forced to prove that the lady under arrest with him was the one that the certificate called for.

Suppose this famous squad of moral lobsters take a turn up to the Portland Hotel and "pinch" every couple they find there without proper credentials. But they won't, although there is probably as much excuse for one as the other. If they are justified in the poorer lodging house they are justified just as well at the Portland Hotel if we are all equal before the law.

Any officer going to any place to make an arrest should have at least

#### WAP'S RECORD IN 1901

We recognized that picture of Wap's, it appeared on the front page of the "P.I." in 1991; all who lived in Seattle during 1901 will remember who Wappenstein is, but for the benefit of the hundred thousand who have come to Seattle since 1901, we will give the facts in order to introduce the gentleman in question. Seattle was a wide-open town in

1901, not only open for gambling, but burglars, foot-pads and sneak thieves were operating under police protection Wappenstein, Mayor Moore's "right bower," was Chief of Detectives. To prove our facts, let us quote from authentic publications as follows:

On Tuesday, May 14, 1901, charges were made that the chief of police was farming out sand bag privileges and blackmailing.. The charges were published in the Seattle "Evening Star." Proof was offered that money was being paid for police protection for surething men. It was charged that gambling houses alone were paying public officials fifteen thousand dollars per month for the privilege of robbing.

The Post-Intelligencer of May 16, 1901, on page 10 published the follow-

"Peculiar methods of Wappenstein came to light yesterday during the trial of Joe Wright, a sure-thing man on the water front. Wright was arrested one month ago on the complaint of H. Miller. Wappenstein Immediately arrested Wright after his first arrest, and had him plead guilty and pay a nom-Inal fine so that the court would dismiss the first case in which Miller was robbed. This would save Wright from exposure in open court. Detective Wappenstein has operated with marked success in preventing trials of gamblers in cases where they would be forced to admit crimes of robbery in open court."

This self same Wappy is Moore's

"P.-I.", May 19, 1901. Editorial in courts and Seattle mothers. part as follows, on tin horn gambling. prostitution and robbery: "It is asking too much of human credulity to believe that this gambling, robbery and proseltution could run openly without some one getting paid, and that someone does pay and pay well to the Chief of Police, and Detective Wappenstein.

It would appear that Wap was the "right bower" of thugs and thieves in 1901 right here in Seattle, Washington,

Not arrest innocent persons and force them to prove their innocence. If he does this, he is more criminal than the one whom he arrests.

But Portland wanted a reform administration and they are getting it. My definition of a modern reformer would be: A person with an ossified brain, hypnotized with a belief in his own absolute goodness and morality deluded to the point of imagining that his own idiosyncrasies are ideal revelations of superior intellectuality. and carrying within his mind the hallucination, that you can force, with a policeman's club, a morality in conflict with the economic conditions under which we live.

Do you better the morality of a community by taking a fallen woman and a pickpocket before a justice or a parson and legalizing their cohabitation, by giving them a piece of paper with a stamp on it and mumbling a few words of hocus pocus, at \$2.50 per?

But what's the use? This hypocrisy will go on, public morals as they are, a stench in the nostrils of every honest person; reform administration a stick to stir the mess, until such time shall come that an intelligent people shall kick both bucket and stick into the sewer of oblivion.

The reading of the accounts of the moral brigade will contaminate the minds of more young people in a week than all the denizens of the restricted district could contaminate in a year. Your moral brigade do as much good as a man would in flood time with a pump drawing the water of the river up and sending it to the sewer to once more wend its way into the same river. Arm your moral brigade with brooms and reform some of your filthy street crossings and some actual good will have been ac complished for the city and its health. THOMAS SLADDEN.

How cruelly his action has falsified their hopes and how fully our condemnation has been justified needs no recapitulation. browbeaten, insulted, and betrayed the unemployed; he has repudiated all his cild professions in favor of the direct employment of labor; he has harried and calumnlated those administrators who have endeavored to combine humane treatment of the poor with purity in public life; he has re-instituted the worst traditions of Poor Law administrations has been supported in the combine of the combine and the combine has been supported by the combine of Poor Law administration; he has ruthlessly and wastefully fustrated the most promising efforts at substituting self-supporting industry for pauper relief, and has proved himself the harshest and most reactionary president of the Local Government Board for a generation. To what fur ther lengths he will go in his pres-ent office it is impossible to say. It is reported that he has won golden opinions from those of our masters whose one idea of Poor Law administration is to grind the faces of the poor. Others, however, are inclined to think he has already gone too far; and it is by no means certain that he and it is by no means certain that he will much longer remain at the Local Government Board. That he aims much higher is quite an open secret. He boasts of being the brains of the Cabinet and aiready has his eye on the premiership. At his present rate of progress, however, he should become the titled Premier in the next Tory administration.—"The Social Democrat," London.

## MILLS DOES NOT DENY

Refuses Offer of "The Socialist" to Print His Side of the Case-Bitterly Attacks Editor of "The Socialist" Instead-Claims He is Worse Treated Than Moyer and Haywood-But Does Not Make the One Simple Statement, "I Never Did It."

Walter Thomas Mills was investigated by the Dominion Executive Committee of the Socialist Party of Canada. That committee found him guilty of supporting candidates of the Canadian Labor Party, a party opposed to the Socialist Party and opposed by the Socialist Party.

The Dominion Committee, having satisfied itself of the facts, after careful investigation, deposited charges against Mills for his compromise tactics, with the State Executive Committee of the State of Washington, The Washington Committee, in obedience to the State Constitution, forwarded the charges to Local Seattle, where Mills holds his membership.

"The Socialist" has published these facts, together with the facts about the attempt of Mills to capture the State organization of Washington. Whether it is Mills or Harper, Debs or Haywood or Simons or Lewis who advocates fusion or compromise or Middle Class principles, this paper will condemn the tactics and pity the individual. If the Editor of "The Socialist" ever himself becomes a Reform Socialist, he will expect and welcome the same treatment he now advocates for others.

# ROOSEVELT ON THE MOYER-HAYWOOD CASE

The President of the United States has written another letter which all the world is talking about. This letter is to explain why he called Moyer, Haywood and Debs "Undesirable Citizens," as undesirable as Harriman, the Railroad Wrecker. Mr. Roosevelt is hearing from Labor Councils in every direction calling him to account for his prejudicing public opinion against men on trial for their lives. Such a storm of protest has reached him, that he feels it necessary to "explain" and "justify" his . . .

How does he do it? BY ASSUM ING A FALSEHOOD. Here is the falsehood Roosevelt as-

sumes. He says:

"Moyer, Haywood and Debs stand as the representatives of the men who by their public utterances and manifestly by the utterances of the papers they control, or inspire, and by the words and deeds of those associated with or subordinated to them, habitually appear as guilty of incitement to, or apology for, bloodshed and violence. If this does not constitute undesirable citizenship, then there can never be any undesirable."

We demand of Theodore Roosevelt that he name "the utterances of the papers they control, or inspire" which incite to violence and bloodshed or which apologize for violence or bloodshed. Let him name those associated with

Moyer, Haywood or Debs who apologize for violence and bloodshed. He cannot do it. He is simply, to use his own "harsher word," a Liar

The President adopts the cheap, ignorant, once popular but now exploded notion of Socialism; that it is the same as Anarchy, and Anarchy of the Deed at that. He is furlous at Class Divisions and Setting of Class against Class and denounces all workingmen as "Understrable Citizens"

own bitter Class feeling and ignorantly displays his own limitations.

For not even the strenuous American President can escape the cold, hard facts of life. What he really hates in Moyer, Haywood and Debs is their open recognition of the Class Struggle and of the economic basis of the Class Struggle.

These men and "those associated with them," as he says, that is, all the Socialists, are constantly teaching that Society is divided into two classes with antagonistic interests. They show by the cold, hard facts of life, that the Class which works for wages is exploited by the Class which pays wages, to the extent of thousands of millions every year. These "Undestrable Citizens," their papers and their associates, are continually proving to the Wage Class that they are mere slaves and urging them to vote their own Emancipation.

Such teachings as there are regarded by Mr. Roosevelt as subversive of Society. He is right. These facts of life are revolutionary facts. They will eventuate in violence and bloodshed if men of the Roosevelt type, stupid and stubborn, control the Capitalist Class. But the undesirable citizen is not he who perceives and proclaims the Facts of Life like Haywood and Debs, but he who blindly and brutally denies those facts, like Roosevelt and Baer and Post.

The Facts of Life are truthfully revealed in our cartoon on this page. The great Wage Class, 15 million strong, carries the Social Structure the capitalist organization and its governments, on its own broad back. At present, that Giant Labor kneels in submission. But men like Debs and Haywood and all their Socialist associates are calling on the kneeling giant to rise in his power, overthrow his Capitalist Masters and reconstruct Society. The Glant is beginning to learn his power and his foolishness. He is struggling to rise to his feet. who talk of the Class Struggle. In Roosevelt feels these first trembling

alarmed and furious. He knows his Class impotence in face of a Working Class uprising.

That is all the bloodshed and viclence we are guilty of. We teach the truth. We refuse to conceal the Class Facts. We point them out as true scientists and true servants of our kind as well. No bloodshed and violence will ever come of our campaign of instruction, unless Roose velt and his Class deny facts and defy facts..

We give you fair and explicit warning Mr. President, that the Wage Class must be dealt with as a Class Your bluster and your threats will only avail to drive us closer together If you go on kidnapping our comrades, declaring them guilty before trial and proclaiming them "Undesirable Citizens,"-you will be doing your best to incite a bloody revolution.

For we give you due notice, you President of a Capitalist Class Government, that we will not submit. We are too strong and we know our power. We have been too long on our knees. No rotten, Christ-denying ecclesiasticism can preach submission any longer to us. We have learned that which you possess, your government and all your government protected wealth, exist only by our permission. They belong to us. We propose to take them.

We want to take our own peaceably, by the ballot. Only you and your silly sort can force us to accomplish our Proletarian Revolution violently and wrathfully, by the bullet. Mr. President, don't strut too much. We will give you credit for being a fighter. But we are fighters, too. Don't underestimate us. Our class is stronger than your class. Our evolutionary class mission is to overthrow your class rule. Debs, Moyer and Haywood are only foam flecks of the coming Tides of Revolution.

Be wise, Mr. President, and stop bravado in the presence of the Social Movement of the Twentieth Century.

CRITICISES HARPER'S BOOKS.

Business Manager "The Socialist." Dear Sir: Your letter to Coblentz and Baker and the Socialist Party of Puyallup inviting discussion of Com-rade Vincent Harper's book, "The Ter-rible Trith About Marriage," which the Trustee Printing Co. is pushing as a Socialist book, was received and

The issue between us is in your question, "Did he not treat the subject from a Socialist standpoint?"

If I thought his treatment of the subject and the endorsement of some Socialist teachers would not tend to bring disgrace and contempt on Socialism, I would not be writing this letter. It is because I believe that no enemy has ever put out a pamphlet that is better calculated to excite envity and prejudice against Socialism. mity and prejudice against Socialism that I decline to line up with a com-pany that is selling and pushing the book. In the first place the title of the book is unfortunate unless Com-rade Harper is opposed to marriage, both natural and artificial. If the title were "The terrible truth about marunder present economic condi-that would do; but there can be neutral ground and no marriage, between conjugal fidelity and licentiousness.

[Of course, Harper speaks of Present Marriage, not of some ideal relation in some other conditions. If Comrade Baker had seen this point he would have agreed with Harper. But we print his letter because it is otherwise well written—except too

long.-Editor.] Comrade Harper argues against marriage in the abstract when he says 'marriage is an institution." Nature "marriage is an institution." Nature knows no institutions, therefore marriage is not in a sense natural. And he kindly informs us that "Socialism has formulated no substitute for marriage." I hope not. The only possible substitute for marriage is promiscuity. What is marriage? It is a little funny that "The best educated man in America" writes a critical and scien-America" writes a critical and scien-tific book without defining his subject,

sons, make and temmie, who are tow-ers, with a view to adding new mem-bers to society.

Marriage is not made by the priest or the civil officer. Parties to the marriage make confession in the presence of friends in accordance with an orderly arrangement of society, and society has a right to require

I cannot conceive of a time when the human race will have advanced to such a stage that it will not be deemed important or necessary for parties entering into an arrangement whereby new members are ushered into society, to make public confession of the fact at or before the time of entering into such relationship.

When a male and female are so over-whelmingly and irresistibly attracted to each other that they cannot take to each other that they cannot take time to submit to an orderly arrangement of society and declare their intentions and thereby show a little regard for their friends and society, but turn themselves loose "in the face of great social perli" society is very justily inclined to consider them as lacking in some of the qualifications and characteristics of good members of society—self-control and moderation, and therefore that they are not the most proper persons to add new members to society.

When two persons are irresistibly

When two persons are irresistibly attracted to each other and turn themselves loose in the face of great social peril, Mr. Harper describes that as being a case in which "Love has its way," and he adds, "God blesses the

union with the most stupendous fruit of the universe—a Human Child; and then Marriage steps in and cries Shame!—and murder results."

That is Mr. Harper's "Terrible Truth about Marriage," and your conception of "Treating the subject from a Socialist standpoint." But I call it an unwarranted slander on marriage.

The truth is the result of that in-

The truth is, the result of that in-tense Love is an "accident," the off-spring of passion, that is not wanted by the parents. At first passion was stronger than regard for the approbation of friends, and society and the innate sense of right. Afterward their regard for friends and Mr. Harper's persontfication of marriage—society— is so far greater than their regard for the most stupendous fruit of the uni-verse, that they hate it unto death.

Mr. Harper appears to be trying to teach us that society ought not to look with disfavor on the conduct of those whose love is only uncontrolable de-sire, the result of which is an "acci-dent," an unwelcome child. He does not seem to know that desire is not love, and that self control, power over one's body, is, an essential qualification for a good Socialist, or any other man; and that those who are deficient in self control are not "Prepared by nature" to add good new members to society. Not knowing these things, society. Not knowing these things, he is "mercilessly frank" in his contention that the offspring of uncontrollable passion, and inhumanly deficient parental love is "Fittest to sur-

Mr. Harper informs us "They do Mr. Harper informs us "Iney do these things better in France." There the government provides for the "love child." It is pleasing to know that there are people in France who have more regard for those unfortunates than their parents have; but it is saddening to know that lovers with such overpowering love for each other that they will break through the bounds overpowering love for each other that they will break through the bounds of all popular propriety, but have no love for their offspring. Alas for society if all were like Mr. Harper's Nature-prepared Lovers. There would be no government to provide for the Love child. Nature requires something more than "Propagation." She requires Love; disinterested, unselfish Love.

Too many people enter into the mar-

Too many people enter into the marriage relation who are unfit to assume its responsibilities; but none are less fit than those who have not a fair deee of self control, and love for coll-But marriage ought not to responsible for the results such unions. Socialism could not

make marriage happy for those who are not adapted to the marriage state.

The influence on the young of Mr. Harper's Intuitionalism is decidedly had. To mate physically and psychologically, i. e., scientifically, requires thorough acquaintance with each other, and all the accumulated knowledge er, and all the accumulates knowledge and experience of the race, relating to the subject. No more important and profound subject was ever brought to the attention of the human mind; and I may add that no subject is less con-sidered and less understood. "Love at first sight" is not the solution.

The human race is not going back to community of wives, nor to polygamy; nor will it continue present promiscuity. Marriage has come to stay; and with industrial and economic liberty, and a knowledge of how to mate wisely and intelligently by scientific "Natural selection," in a little while the terrible truth about the sexual relation, in and out of marriage, will be remembered as a horrible dream.
